

COUNTY OF BERGEN NOTICE OF PUBLIC HEARING REGARDING THE COUNTY'S INTENTION TO ADOPT NEW JERSEY DEPARTMENT OF TRANSPORTATION CONTRACTOR PREQUALIFICATION CLASS CODES AS ITS OWN PREQUALIFICATION REGULATIONS FOR ALL CONSTRUCTION CONTRACTS VALUED AT MORE THAN \$5,000,000.00 FOR PROJECTS FUNDED, IN WHOLE OR IN PART, OUT OF FUNDS FROM THE STATE OR LOCAL AID PROGRAM FOR A PERIOD OF FIVE (5) YEARS.

PLEASE TAKE NOTICE that the Bergen County Board of County Commissioners will hold a public hearing on September 6, 2023, commencing at 7:00 p.m. in the Public Meeting Room located at One Bergen County Plaza, 5<sup>th</sup> Floor, Hackensack, New Jersey 07601, pursuant to N.J.S.A. 40A:12-25 of the Local Public Contractors Law on the County's intention to adopt New Jersey Department of Transportation Contractor Prequalification Class Codes as its own prequalification regulations for all construction contracts valued at more than \$5,000,000.00 for projects funded, in whole or in part, out of funds from the state local aid program for a period of 5 years.

PLEASE TAKE FURTHER NOTICE that subject to the notification and approval pursuant to N.J.A.C 1620A-6.2, and in accordance with the provisions of the Local Public Contracts Law, N.J.S.A 40A:11-1 et seq., the County shall advertise and award for construction contracts for a project being advanced by the County and listed in its Annual Transportation Project (ATP).

PLEASE TAKE FURTHER NOTICE the Bidder shall meet New Jersey Department of Transportation Contractor Class Codes in order to submit a bid for a construction contract valued at more than \$5,000,000.00 for projects funded, in whole or in part, out of funds from the local aid program.
