### ADDRESSING COERCIVE CONTROL IN THE LEGAL SYSTEM

Coercive control is a form of psychological abuse that undermines a person's autonomy and well-being through tactics such as manipulation, intimidation, and emotional or economic deprivation. It often manifests in a pattern of controlling behaviors that can leave victims feeling trapped in their relationships.

In a significant step towards addressing this issue, on January 18, 2024, New Jersey's Governor Phil Murphy signed a law that recognizes coercive control in civil restraining order cases. This legislation allows victims to present evidence of coercive control during restraining order hearings as a legitimate reason for seeking protection. It aims to provide survivors with more legal options and support, and to recognize how serious this abuse can be.

According to the National Coalition Against Domestic Violence, nearly 1 in 4 women and 1 in 9 men experience severe intimate partner physical violence, but a staggering 50% of women and 40% of men report experiencing psychological aggression from an intimate partner. Additionally, research shows that victims of coercive control often face challenges within the legal system. Many report feeling that law enforcement and courts fail to recognize or comprehend their experiences.

ADV welcomes more efforts to educate the public about coercive control and other covert forms of abuse in our systems. We also invite advocates working within or in proximity to the legal system to recognize the impact of coercive control and to take a stand against systemic violence by joining <u>Bergen County's</u> <u>Coordinated Community Response to Domestic & Sexual Violence (CCR-DSV).</u>

# SERVICE HIGHLIGHTS/UPDATES

### Legal Assistance & Advocacy Services



- 66% of domestic violence victims who seek a protective order do not have legal representation
- 50% of victims report not being able to afford an attorney
- Victims of abuse are 70% more likely to experience further violence if they do not have legal protection

ADV offers Legal Assistance & Advocacy services for survivors of domestic violence and dating abuse. Our team of trained legal advocates provide free services to community members seeking civil legal remedies and protections against abuse.

#### **Court Preparation Services**

Our court preparation services assist survivors who are interested in or have filed a temporary restraining order (or protective order) in civil court. Our trained legal advocates provide survivors with one-on-one orientation to the process of obtaining both temporary and/or final restraining orders Bergen County, review safety concerns, and linkage survivors to other community resources.



#### Domestic Violence Legal Advocacy Project (DVLAP)

Our Domestic Violence Legal Advocacy Project (DVLAP) allows ADV's legal advocates to screen survivors of domestic violence for their eligibility to receive pro bono legal representation in an upcoming restraining order hearing.



#### **Court Accompaniment**

Our court accompaniment services are available to plaintiffs seeking Temporary or Final Restraining Orders in Bergen County Superior Court. Legal advocates connect with survivors the day of their restraining order healing, provide them with legal education and emotional support, and linkage them to community resources.

#### **Information and Referrals**

ADV's team of advocates can provide clients with information and referrals to community partners that may assist with family law rights, such as relating to child custody and visitation, establishing parentage, child support and spousal support, divorce, and legal separation. We can also provide immigrant clients with referrals, advocacy, and help in assessing what immigration relief they might qualify for as victims of domestic violence.

# KNOW YOUR LEGAL RIGHTS: DOMESTIC VIOLENCE LAW 101

In New Jersey, domestic violence is defined under the New Jersey Prevention of Domestic Violence Act (PDVA) (N.J.S.A. 2C:25-19). According to this law, domestic violence refers to certain criminal acts and behaviors committed by one individual against another in a domestic context. The law specifically recognizes domestic violence when it occurs between:

SPOUSES OR FORMER SPOUSES

PARTNERS OR FORMER PARTNERS IN A DATING RELATIONSHIP INDIVIDUALS WHO ARE PRESENT OR FORMER HOUSEHOLD MEMBERS

INDIVIDUALS WHO HAVE A CHILD TOGETHER

The PDVA protects individuals 18 years of age or older, or who are emancipated minors, and who have been subjected to the following criminal offenses:

The PDVA grants victims of domestic violence the right to file both civil and criminal complaints. Criminal complaints can be filed at your local police station, and civil complaints can be filed both at your local police station or at Superior Court. # SURVIVOR RESOURCE SPOTLIGHT

#### NORTHEAST NEW JERSEY LEGAL SERVICES

Northeast New Jersey Legal Services' (NNJLS) mission is to ensure equal access to justice for residents of Bergen, Hudson, and Passaic Counties, NJ who are experiencing poverty. No one should be denied a meaningful opportunity to have their day in court simply because they cannot afford a lawyer. NNJLS focuses on four core areas of civil law- housing, consumer, family, and public benefits.

Their Family Law Unit provides legal representation and advice for issues affecting family and domestic relationships. They help survivors of domestic violence and survivors of sexual assault obtain restraining orders and other relief to keep them and their families safe and secure from violence.

For survivors of domestic violence, NNJLS can help with:

- Final Restraining Order (V) or Final Protection Order (SA)
- relief such as custody, support, and possession of a residence
- other civil legal matters that result from victimization, such as housing, immigration, and federal tax issues
- referral to partner agencies for counseling and safety planning
- assistance with New Jersey Victims of Crime Compensation claims

Family issues NNJLS can help with include:

- custody
- child support
- spousal support/alimony
- parenting time/visitation
- uncontested divorce

# ady's training institute on domestic violence

ADV's Training Institute on Domestic Violence provides online and in-person training for community advocates and professionals to enhance their skills in assisting domestic violence survivors. The training aims to empower advocates to interrupt abuse and intervene effectively for survivors.

The <u>40-Hour Training Program</u> is open to all and is especially geared toward individuals and groups looking to volunteer or work directly with survivors of domestic violence at victim service agencies requiring victim privilege certification. The training provides a comprehensive overview of domestic violence topics, including in-depth exploration of abuse dynamics in intimate relationships, the effects of abuse on diverse survivor populations, and anti-oppressive perspectives on abuse intervention and healing work.

The training operates in a cohort model with both live virtual sessions and independent self-paced modules granting participants additional flexibility. We offer the training four times per year with additional offerings on request. Participants are required to participate in live virtual ZOOM sessions to receive credit.
